1. This form is valid for the period of time your child attends St Dunstan’s Catholic School.
2. Photographs or video recordings may exist after your child leaves this school, they may be kept for historical and/or commemorative purposes.
3. We will not use the personal details or full names (which means first name and surname) of any child or adult in a photographic image on video, on our website or social media, in our school prospectus or in any of our other printed publications without good reason. For example, we may include the full name of a pupil in a newsletter to parents if the pupil has won an award.
4. If we name a pupil in the text, we will not use a photograph of that child to accompany the article without good reason. (See point 3 above.)
5. We will not include personal e-mail or postal addresses, or telephone or fax numbers on video, on our website, in our school prospectus or in other printed publications.
6. We may include pictures of pupils and teachers that have been drawn by the pupils.
7. We may use group or class photographs or footage with very general labels, such as ‘a science lesson’ or ‘making Christmas decorations’.
8. We will only use images of pupils who are suitably dressed, to reduce the risk of such images being used inappropriately.
9. Your consent can be withdrawn at any time in writing using the consent withdrawal form available from the school website or the school office.
